

## Vancouver Sun Rewards and Province Perks Jann Arden Contest

THE VANCOUVER SUN REWARDS AND PROVINCE PERKS JANN ARDEN CONTEST (THE "**CONTEST**") IS INTENDED TO BE CONDUCTED IN BRITISH COLUMBIA ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. THE CONTEST IS OPEN TO BRITISH COLUMBIA RESIDENTS ONLY AND PARTICIPANTS MUST BE THE AGE OF MAJORITY OR OLDER IN THE PROVINCE OF BRITISH COLUMBIA AT THE TIME OF ENTRY. VOID IN WHOLE OR IN PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "**CONTEST RULES**").

**ELIGIBILITY.** To be eligible for this Contest, an individual must:

- (a) be a legal resident of the province of British Columbia;
- (b) be of the age of majority or older in British Columbia at the time of entry; and
- (c) be a current subscriber of the Vancouver Sun and/or Province newspaper (online or in print) as of 12:01 a.m. PT, November 04, 2011.

Employees of The Vancouver Sun and The Province, a division of Postmedia Network Inc., its subsidiaries, parents and/or affiliates ("**Postmedia**" and collectively, the "**Sponsors**"), their respective affiliates, subsidiaries, related companies, advertising and promotional agencies, and the household members of any of the above, are not eligible to participate in the Contest.

The Sponsors shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the Sponsors for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

**CONTEST PERIOD.** The Contest begins at 12:01 a.m., Pacific Time ("**PT**") on November 4, 2011, and ends at 11:59 p.m. PT on November 24, 2011 (the "**Contest Period**") after which time the Contest will be closed and no further entries shall be accepted.

### **HOW TO ENTER.**

(a) There is no purchase necessary to enter the Contest. Enter using any of the methods of entry outlined below. No entries will be accepted by any other means.

(ii) For no purchase entries, clearly print your name, complete mailing address, daytime telephone number, email address and date of birth on a plain piece of paper and submit it to the attention of The Vancouver Sun Rewards/ The Province Perks Jann Arden Contest, 1-200 Granville Street, Main Floor, Vancouver, BC, V6C 3N3.

(b) Limit of one (1) entry per person per e-mail address during the Contest Period. In the case of multiple entries, only the first eligible entry will be considered.

(c) All entries become the sole property of the Sponsors and none will be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. No communication or correspondence will be exchanged with entrants except with those selected for the Prize.

(d) Entries submitted by mail must be received by the Sponsors no later than the end of the Contest Period, and must be in a separate outer envelope bearing sufficient postage.

(e) Entries received online shall be deemed to be submitted by the authorized account holder of the e-mail address associated with the entry. For the purpose of the Contest Rules, "authorized account holder" of an e-mail address is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Each selected entrant may be required to provide the Sponsors with proof that the selected entrant is the authorized account holder of the e-mail address associated with the winning entry.

#### **PRIZE.**

**Grand Prize.** There is one (1) Grand Prize available to be won by the Prize winner (**Grand Prize Winner**), consisting of: a PRIVATE meet & greet at the Metrotown signing in Burnaby, B.C. with Jann Arden, a copy of her new "Uncover Me 2" CD and her new book "Falling Backwards: A Memoir."

Grand Prize has an approximate value of forty-five dollars (\$45.00 CDN.)

**Secondary Prizes.** There are four (4) prizes available to be won by the Secondary Prize winners (each a "**Secondary Prize Winner**"), consisting of: a copy of her new "Uncover Me 2" CD and her new book "Falling Backwards: A Memoir."

Each Grand Prize has an approximate value forty-five dollars (\$45.00 CDN.)

Winner is not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.

Winners may claim his/her Prize in Metrotown at Burnaby, British Columbia on November 28, 2011.

(e) Winner must be available to attend the book signing on November 28, 2011, in Burnaby, British Columbia. Should Winner be unable to attend on the date and time designated by the Sponsors, the Prize will be forfeited and awarded to an alternate winner. Winner will be responsible for (without limitation) transportation to and from Burnaby, British Columbia, any local transportation costs, travel and medical insurance, travel documentation, taxes, gratuities, telephone calls, in-room charges, meals and alcoholic and non-alcoholic beverages and any other expense not explicitly included in the Prize.

(f) Prize must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of the Sponsors. Any unused portion of the Prize will be forfeited and have no cash value. The Sponsors reserve the right, in

its and their sole discretion, to substitute a prize of equal or greater value if the Prize (or any portion thereof) cannot be awarded for any reason.

#### **WINNER SELECTION.**

Five (5) Winners shall be selected as follows:

(a) On or about November 25, 2011 in Vancouver, British Columbia, five (5) entrants will be selected by a random draw from all eligible entries received during the Contest Period. Each entrant shall be eligible to win only one (1) Prize. The odds of being selected as a potential winner are dependent upon the number of eligible entries received by the Sponsors. Before being declared a Winner, the selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail, to comply with the Contest Rules and sign and return the Release (described below).

Upon notification, the selected entrant must respond by telephone to the contact number provided in the notification, and the selected entrant's response must be received by the Sponsors within two (2) days of such notification. If the selected entrant does not respond in accordance with the Contest Rules, he/she will be disqualified and will not receive a Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsors to receive a selected entrant's response.

(c) If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the correct number of Prizes.

#### **RELEASE.**
