

THE VANCOUVER SUN SUBSCRIBER REWARDS BC LIONS CONTEST

THE VANCOUVER SUN SUBSCRIBER REWARDS BC LIONS CONTEST (THE "CONTEST") IS INTENDED TO BE CONDUCTED IN CANADA ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCE OF **BRITISH COLUMBIA** OR OLDER. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

1. ELIGIBILITY. To be eligible for this Contest, an individual must:

be a legal resident of British Columbia;

be of the age of majority in British Columbia or older at the time of entry

Employees of The Vancouver Sun, a division of Postmedia Network Inc., (collectively, the "Sponsors"), their respective affiliates, subsidiaries, related companies, advertising and promotional agencies, and the household members of any of the above, are not eligible to participate in the Contest.

The Sponsors shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the Sponsors for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

2. CONTEST PERIOD. The Contest begins at 12:01 a.m. Pacific Standard Time ("PST") on Monday, July 25, 2011 and ends at 11:59 p.m. PST on Sunday, August 7, 2011 (the "Contest Period") after which time the Contest will be closed and no further entries shall be accepted.

3. HOW TO ENTER.

There is no purchase necessary to enter the Contest. Enter using any of the methods of entry outlined below. No entries will be accepted by any other means.

Entries must be received by the deadlines listed above.

- (d) Limit of one (1) entry per person during the Contest Period. A person submitting multiple entries will be disqualified.
- (e) All entries become the sole property of the Sponsors and none will be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. No communication or correspondence will be exchanged with entrants except with those selected for a Prize.
- (f) Entries submitted by mail must be received by the Sponsors no later than the end of the Contest Period, and must be in a separate outer envelope bearing sufficient postage.
- (g) Entries received online shall be deemed to be submitted by the authorized account holder of the e-mail address associated with the entry. For the purpose of the Contest Rules, “authorized account holder” of an e-mail address is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. PRIZES.

Grand Prizes. There are eight (8) grand prizes (each, a “Grand Prize”) available to be won by the (each, a “Grand Prize Winner”) consisting of: two suite tickets to the BC Lions vs the Winnipeg Blue Bombers on Saturday, August 13 2011, from The Vancouver Sun Suite at Empire Field, Vancouver, B.C., and to view the pre-game warm up.

Each Grand Prize has an approximate value of three hundred dollars (CDN \$300.00).

Secondary Prizes. There are sixteen (16) secondary prizes (each, a “Secondary Prize”) available to be won by the Secondary Prize winners (each a “Secondary Prize Winner”), which consists of: consisting of: two tickets to the BC Lions vs the Winnipeg Blue Bombers on Saturday, August 13 2011, at Empire Field, Vancouver, B.C., and to view the pre-game warm up.

Each Secondary Prize has an approximate retail value one hundred and fifty (CDN \$150.00).

Third Prizes. There are eight (8) third prizes (each, a “Third Prize”) available to be won by the Third Prize winners (each a “Third Prize Winner”), which consists of: consisting of: two tickets to the BC Lions vs the Winnipeg Blue Bombers on Saturday, August 13 2011, at Empire Field, Vancouver, B.C.

Each Third Prize has an approximate retail value seventy dollars (CDN \$70.00). Grand Prizes, Secondary Prizes, and Third Prizes are hereafter collectively referred to as “Prize” or “Prizes”. Grand Prize Winners, Secondary Prize Winners and Third Prize Winners are hereafter collectively referred to as a “Winner” or “Winners”.

The prizes are non- refundable and non-commissionable. They cannot be modified or exchanged for cash value.

The Winners may claim their Prize in Vancouver, B.C. once they have been successfully contacted and notified of his/her Prize and fulfilled the requirements set out herein.

Winners will be contacted within two days of the draw date.

Prizes must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of the Sponsors. Any unused portion of a Prize will be forfeited and have no cash value. The Sponsors reserve the right, in its and their sole discretion, to substitute a prize of equal or greater value if a Prize (or any portion thereof) cannot be awarded for any reason.

Shipped Prizes shall not be insured and The Sponsors shall not assume any liability for lost, damaged or misdirected Prizes.

5. WINNER SELECTION.

Thirty-two (32) Winners shall be selected as follows:

On or about Monday, August 8, 2011 in **Vancouver, B.C.**, thirty-two (32) entrants will be selected by a random draw from all eligible entries received during the Contest Period. Each entrant shall be eligible to win only one (1) Prize. The odds of being selected as a potential winner are dependent upon the number of eligible entries received by the Sponsors.

Before being declared a Winner, the selected entrant must have correctly answered the trivia question from the contest to comply with the Contest Rules and sign and return the Release (described below).

The judges, in their absolute discretion, shall select the Winners based upon the above criteria. The decisions of the judges shall be final and binding and may not be challenged in any way.

Upon notification, the selected entrant must respond by telephone to the contact number provided in the notification, and the selected entrant's response must be received by the Sponsors within two (2) business days of such notification. If the selected entrant does not respond in accordance with the Contest Rules, he/she will be disqualified and will not receive a Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsors to receive a selected entrant's response.

If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the correct number of Prizes.

6. RELEASE. Winners will be required to execute a legal agreement and release

The Sponsors assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries. The Sponsors are not responsible for any problems, failures or technical malfunction of any telephone network or lines, computer online systems, servers, providers, computer equipment, software, e-mail, players, or browsers, on account of technical problems or traffic congestion on the Internet, at any website, or on account of any combination of the foregoing or otherwise. The Sponsors are not responsible for any injury or damage to entrant or to any computer related to or resulting from participating or downloading materials in this Contest. Entrant assumes liability for injuries caused or claimed to be caused by participating in the Contest, or by the acceptance, possession, use of, or failure to receive any Prize. The Sponsors assume no responsibility or liability in the event that the Contest cannot be conducted as planned for any reason, including those reasons beyond the control of the Sponsors, such as infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or corruption of the administration, security, fairness, integrity or proper conduct of this Contest, the

The Sponsors reserve the right, in their sole discretion, to disqualify any entrant found to be: (a) violating the Contest Rules; (b) tampering or attempting to tamper with the entry process or the operation of the Contest; the Contest Website, or any canada.com website; (c) violating the terms of service, conditions of use and/or general rules or guidelines of any canada.com property or service; and/or (d) acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person.  - (b) By opting-in online you consent to The Vancouver Sun’s and any of its corporate affiliate’s use of your Personal Information to contact you to promote draws and contests similar to the **The Vancouver Sun Rewards BC Lions Contest**, promote opportunities to subscribe to newsletters or promotional clubs, and notify you about related products or services.
 - (c) The Sponsors will use the entrant’s Personal Information only for identified purposes, and protect the entrant’s Personal Information in a manner that is consistent with the Postmedia Network Privacy Policy located at www.canada.com/aboutus/privacy.html.

13. **TERMINATION.** Sponsors reserve the right, in their sole discretion, to terminate the Contest, in whole or in part, and/or modify, amend or suspend the Contest, and/or the

Contest Rules in any way, at any time, for any reason without prior notice.

LAW. These are the official Contest Rules. The Contest is subject to applicable federal, provincial and municipal laws and regulations. The Contest Rules are subject to change without notice in order to comply with any applicable federal, provincial and municipal laws or the policy of any other entity having jurisdiction over the Sponsors.
